



## WEALTHTRAC EMPLOYER SUPERANNUATION CONTRIBUTIONS

Use the form attached to have your employer superannuation contributions paid to your Wealthtrac Superannuation Master Trust account.

### Contributing via SuperStream

Wealthtrac Superannuation Master Trust accounts are able to receive employer contributions via SuperStream.

Employers or their service providers will require your account details and the following fund information to send contribution information and payments via SuperStream:

- Unique Superannuation Identifier (USI) and superannuation product name
- Australian Business Number (ABN)
- Electronic service address.

The USI and ABN for the Wealthtrac Superannuation Master Trust, are provided on the next page of this form.

Employers or their payroll service providers can use the USI and ABN to identify the individual super product on the Australian Taxation Office's Fund Validation Service in order to obtain the crediting details and electronic service address for that super product.

### Other ways to contribute

For employers who have not transitioned to sending contributions via an eligible SuperStream method, there are several other ways in which they can continue to contribute to your account.

Please note our direct credit (direct deposit facility) and BPAY® payment options for employer contributions are not eligible SuperStream contribution formats.

#### 1. Contributing via Direct deposit plan

Please contact your financial adviser should your employer wish to contribute via Direct deposit.

#### 2. Contributing via BPAY

- a) Login to internet banking or telephone banking.
- b) Select the BPAY or bill payment option and follow the instructions to enter the appropriate biller code based on the contribution type, your Customer Reference Number/BPAY Reference Number and contribution amount.
- c) Wait for the transaction to process and record the receipt number.

To make multiple contributions, simply repeat the process.

## Complying superannuation fund

The Fund is a complying, resident, regulated superannuation fund under the *Superannuation Industry (Supervision) Act 1993* (SIS Act). The Fund is not subject to a direction under section 63 of the SIS Act, nor does it expect to receive such a direction.

## Contributions

The Fund is able to accept superannuation guarantee contributions as well as other additional employer contributions.

The trust deed governing the Fund also allows benefits to be transferred from other resident regulated superannuation funds into the Fund, and allows benefits to be transferred or rolled over from the Fund to other resident regulated funds.

Wealthtrac Superannuation Master Trust offers insurance that meets the minimum requirements set out in the *Superannuation Guarantee (Administration) Act 1992*.

Members may only cash preserved benefits in circumstances permitted by the SIS Act.
